

WHEREAS, April 16th is National Healthcare Decision Day designated to increase public awareness about the importance of written documents that explain individual preferences in healthcare decisions, such as advance directives for end of life; and

WHEREAS, it is estimated that only one in three US adults completes any type of advance directive for end-of-life care, and even fewer have written descriptions of the type of care they want if incapacitated and in need of medical care; and

WHEREAS, written directives can alleviate unnecessary suffering, improve quality of life, and support adults at any age or stage of health in understanding and sharing their personal values, life goals, and preferences regarding future medical care; and

WHEREAS, advance healthcare planning is not just for those who are facing end of life or terminal illness; and

WHEREAS, The Survivorship and Palliative Care Task Force of the Colorado Cancer Coalition supports individuals in getting the planning and care tools that they need;

THEREFORE, I, Jared Polis, Governor of Colorado, do hereby proclaim April 16, 2021 as



In the year of our Lord Two Thousand and Nineteen

HEALTHCARE DECISIONS DAY
APRIL 16, 2019

WHEREAS, Healthcare Decisions Day is designed to raise public awareness of the need to plan ahead for health care decisions related to serious illness or end of life care and medical decision-making whenever patients are unable to communicate for themselves, and to encourage the specific use of advance directives to convey these important health care decisions; and

WHEREAS, in New Hampshire, the Foundation for Healthy Communities provides the information on advance care planning and offers a model form for public use; and

WHEREAS, it is estimated that only about 20 percent of people in New Hampshire have executed an advance directive. Moreover, it is estimated that less than 50 percent of severely or terminally ill patients have an advance directive; and

WHEREAS, it is likely that a significant reason for these low percentages is that there is both a lack of knowledge and considerable confusion in the public about Advance Directives; and

WHEREAS, one of the principal goals of Healthcare Decisions Day is to encourage hospitals, nursing homes, assisted living facilities, continuing care retirement communities, and hospices to participate in a State-wide effort to provide clear and consistent information to the public about advance directives, as well as to encourage medical professionals and lawyers to volunteer their time and efforts to improve public knowledge and increase the number of New Hampshire citizens with advance directives; and

WHEREAS, the Foundation for Healthy Communities and other organizations throughout New Hampshire have endorsed this event and are committed to educating the public about the importance of discussing health care choices and executing advance directives; and

WHEREAS, as a result of April 16, 2019, being recognized as Healthcare Decisions Day in New Hampshire, more citizens will have conversations about their health care decisions; more citizens will execute Advance Directives to make their wishes known; and fewer families and health care providers will have to struggle with making difficult health care decisions in the absence of guidance from the patient;

NOW, THEREFORE, I, CHRISTOPHER T. SUNUNU, GOVERNOR of the State of New Hampshire, do hereby proclaim **APRIL 16, 2019** as **HEALTHCARE DECISIONS DAY** in the State of New Hampshire, and call this day to the attention of all citizens.

Proclamation

WHEREAS, in New Jersey, N.J.S.A. § 26:2H-58 allows individuals to name a durable power of attorney for healthcare and N.J.S.A § 26:2H-53 provides the specifics for a healthcare directive, offering a model form for patient use; and

WHEREAS, health care organizations across New Jersey are assisting residents to plan ahead for future healthcare decisions in the event that they are unable to make their own medical decisions and to encourage the use of advance directives to communicate these important healthcare decisions; and

WHEREAS, according to a report by the New Jersey Healthcare Quality Institute, it is estimated that 60 percent of people in New Jersey have not put their end-of-life wishes in writing, and 38 percent have not had conversations expressing their end-of-life wishes; and

WHEREAS, a significant reason for these low rates may be the lack of knowledge and considerable confusion about advance care planning and advance directives; and

WHEREAS, National Healthcare Decisions Day is designed to inspire, educate, and empower the public and healthcare providers about the importance of advance care planning and encourage physicians and care teams, medical groups, hospital and health systems, nursing homes, assisted living facilities, retirement communities, and hospices to participate in a statewide effort to provide clear and consistent information to the public about advance care planning; and

WHEREAS, conversations about healthcare decisions and the execution of advance directives that make patients' wishes known, will mean that fewer families and healthcare providers will struggle with making difficult healthcare decisions in the absence of guidance from the patient;

NOW, THEREFORE, I, Philip D. Murphy, Governor of the state of New Jersey, do hereby proclaim:



A Proclamation

WHEREAS, serious illness, accident or injury can happen to anyone at any time regardless of age or health status; and

WHEREAS, it is in everyone's best interest to have their goals and values known at times of incapacity and end-of-life; and

WHEREAS, under the Laws of 2005, Act No. 55 (the "Act"), the state expressly recognized the fundamental right of an adult to determine the extent of health care the individual will receive, including treatment provided during periods of incapacity and at the end-of-life and enabled adults to retain control over their own health care through the use of advance directives; and

WHEREAS, as directed by the Act, the Vermont Department of Health developed and now maintains an electronic Advance Directive Registry where individuals may register Advance Directives online to ensure critical health care decisions will be honored by hospitals and other health care providers who need quick access to them in an emergency; and

WHEREAS, by completing an Advance Directive, Vermonters are able to communicate their health care goals, preferences and priorities in advance of a health crisis.




